

CONSENT TO THE PROCESSING OF PERSONAL INFORMATION

By granting this consent to the processing of your personal data, you agree that Valsabbia Praha, s.r.o., Company ID: 250 74 466, with its registered office U Dýchárny 946, 278 01 Kralupy nad Vltavou, File number 47344 C maintained at Municipal Court in Prague (hereinafter referred to as „Administrator“) has processed your personal information in accordance with the terms and conditions below mentioned.

Scope of your personal information processing

The administrator will process your personal information to the extent you provided it in connection with the use of the form or, alternatively, for the application to be included in the register of job seekers. The administrator will process primarily the first name, surname, email, telephone number and other information provided in the contact form alternatively in your resume.

Purpose of your personal information processing

The administrator will process your personal information in order to provide the information you require. In the case of a job vacancy, for related purposes.

Legal basis for the processing of personal information

The legal basis for the processing is your consent and the fact that your personal information is necessary for the fulfilment of the individual purposes and obligations to process your claim, or to include you in records of job seekers. Personal data is processed in accordance with the General Regulation on Personal Data Protection – Regulation of the European Parliament and Council (EU) 2016/679 of 27.4.2016 - (hereinafter referred to as „GDPR“).

The time during which your personal information will be processed

The administrator will process your personal data and information in connection with the above-mentioned purposes for a period of 1 year if you do not withdraw this consent and then in accordance with the laws of the Czech Republic.

Revocation of consent to the processing of personal information

You may at any time revoke this voluntarily granted consent with processing of your personal data and information free of charge by the means of sending an email to: valsabbia@valsabbia.cz. Revocation of consent is without prejudice to the lawfulness of processing based on consent given prior to its removal. Revocation of consent also has no effect on the processing of personal data processed by the controller based on the legal basis other than consent.

Persons with access to your personal information

Your administrator will have access to your personal information. That means, selected employees and, if applicable, third parties – processors who provide appropriate warranties and whose processing meets all GDPR requirements and who will adequately protect your rights and your personal information. These developers are web hosting providers and their subsidiaries. However, these persons will only have access to these data for as long as it is strictly necessary and to the extent strictly necessary for the provision of the service and the fulfilment of the legal requirements.

Contact details of the administrator

The administrator is entitled to request proof of your identity in order to prevent unauthorized persons from accessing your personal data.

Your rights related to the protection of your personal information

You have the right to withdraw your consent at any time, to correct or add personal data, to request processing restrictions, to object or to complain against the processing of personal data, to request data transfer, access to your personal data, to be informed about breach of the protection of your personal data, deletion and other rights stated in GDPR.

Right to object

You have the right to object to the processing of your personal data and information if it is processed by the trustee for direct marketing purposes. The objection must be filled with the administrator. In case you object to processing for direct marketing, the administrator does not further process personal data to this extent unless he/she can prove that there are serious legitimate reasons for processing that outweigh your interests or rights and freedoms or for determining, exercising or defending legal claims. For more information on this right, please refer in particular to Article No.21 GDPR.

Right to file a complaint with the Supervisory Authority

At any time, you may make a complaint regarding the processing of your personal data on the failure to comply with the GDPR's controller's obligations to the Supervisory Authority. The Supervisory Authority is the Office for personal Data Protection in the Czech Republic, with business address Plk. Sochora 27, 170 00 Prague 7, www.uouu.cz.

Obligation to provide personal data. Consequences of non-disclosure of personal information

You provide your personal information entirely voluntarily. If we do not provide the necessary data, we will unfortunately not be able to answer your question or place you among the job applicants.
